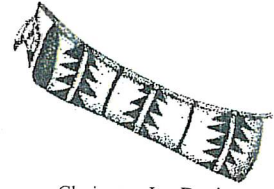



The Hoopa Valley Tribe is only eligible to submit one ICDBG Proposal, therefore, each department who would like to apply for the grant shall submit a the "Grant Project Summary Form," with any project back-up, (draft proposal, budget, conceptual/images, etc), to the Planning Department. The Planning Department and the Hoopa Valley Tribal Council (HVTC) will review the submitted Projects and the HVTC will make a final selection for the grant submission. This process may also include a project presentation to the HVTC and the Planning Department.

Monday, July 31, 2023, 5:00pm:

The deadline to submit the Draft Grant Proposal with budget, to the Planning Department for consideration to apply for this funding.

Friday, August 4, 2023:

Selection by HVTC of the Tribal in-house winning proposal.

Tuesday, September 5, 2023:

If your proposal is selected for grant submission, the Planning Department will assist you with submitting your grant application to the funding agency, the U.S. Department of Housing and Urban Development (HUD).
